Using the Security Lock

You can secure the Dock I and the computer by using the security lock on the front of the Dock I. The following describes the security lock and shows the various ways to use it.


Security Lock Description

The security lock secures the following:

Bottom Cover	When the bottom cover is locked by the security lock, the bottom cover cannot be removed to protect options installed in the Dock I.			
Computer	The computer cannot be removed when the key position is <i>Lock 1</i> or <i>Lock 2</i> . When you attach or remove the computer to or from the Dock I, set the key position to <i>Unlock</i> . For the key positions, see "Key Positions and Their Functions."			
Power	The Dock I power cannot be turned on when the power is locked by the security lock.			

Key Positions and Their Functions

The following shows the key positions of the security lock and their corresponding functions.












You can secure the Dock I to a table or desk by routing a chain or cable through the security hook at the rear of the Dock I.

- Note

You must purchase the chain or cable and lock. The diameter of the chain or cable must be approximately 4 mm (0.15 in.) or less.

Handling Internal Options

Warning: Do not open the static-protective package containing the option until you are instructed to install the option. Static electricity can damage the option.

When you are instructed to install the option, observe these precautions as you open the static-protective package:

Touch the static-protective package containing the option to a metallic portion of the Dock I for at least 2 seconds. This action reduces the static electricity from the package and from your body.

Do not touch any exposed circuitry on the option.

Prevent other people from touching the option.

Limit your movement. Movement can cause static-electricity buildup.

Always handle the option carefully and by its edges.

If you *must* put the option down after it has been removed from the package, place the option on the static-protective package on a level surface. Do not place the option on a metal table.

The configuration of the SCSI controller is preset to the default. The default settings will serve most installations.

The default configuration of the SCSI controller and ROM BIOS is set up as follows.

The SCSI controller uses no DMA channels and no I/O ports. All operations are memory-mapped I/O.

The standard configuration uses 8K of memory space at address CA00h in the system (the area reserved for ROM BIOS), and uses Interrupt Level 11.







Ensure that no more than 3 meters (approximately 10 feet) total maximum of cable length are used.

There are eight SCSI IDs—7 through 0. SCSI ID 7 is reserved exclusively for the SCSI controller. Each device must have a unique SCSI ID. You can set your devices—a maximum of 5—to any of the other available SCSI IDs.

Due to the method by which the SCSI controller services option devices, follow the guidelines below for establishing device SCSI IDs:

If you are installing:

IBM 3.5-inch SCSI Rewritable Optical Disk Drive, or IBM 5.25-inch SCSI Rewritable Optical Disk Drive

The PLAYCD utility program is not installed during this installation procedure. The PLAYCD.EXE and CDPLAY.HLP files are available on the CD-ROM Option/Device Driver Diskette. If these files are needed, use the OS/2 COPY command to copy the individual files from the option diskette.

Now installation is complete.

Using the SCSI Diagnostics Utility

This section explains how to prepare your hard disk drives for use with your computer system and how to identify the problems with the SCSI diagnostics utility (FDSDA.EXE).

Preparing SCSI Drives

If your SCSI drive has been used previously in another system configuration, it is advisable to run a low-level format first with the SCSI diagnostics utility.

Then run your IBM DOS or OS/2 FDISK and FORMAT utilities to partition and format the drives in accordance with your IBM DOS or OS/2 documentation.

The low-level format prepares a drive to work with an operating system. It also scans the disk surface and builds a defect list to relocate any defective sectors to a known good area of the disk.





If your SCSI drives are new, using the appropriate IBM DOS or OS/2 utility programs is the only step you need.

The SCSI diagnostics utility helps you troubleshoot SCSI controller and device problems through a series of menus.

Starting the SCSI Diagnostics Utility

This section explains how to run the SCSI diagnostics utility from the Dock I Option Diskette to verify the configuration you just installed.

To start the SCSI diagnostics utility, do the following.

1.

Insert the Dock I Option Diskette into drive A.

2.


Turn on all attached devices, then turn on the computer.

3.

In the main menu, select "Diagnostics". Then select "Test SCSI Subsystems". This screen appears. Note that in this screen the Dock I SCSI controller is referred to as adapter. Press Enter.

Note

If you have not attached a SCSI device to the Dock I SCSI controller, the diagnostics utility reports an error that no SCSI host adapters were not found.



The cursor highlights the first option device, which is the device with the lowest SCSI ID. Select the device you want to test by highlighting the device and pressing **Enter**.





The SCSI FIXED/REMOVAL DRIVE MENU appears. This menu lists 7 possible test options. If your installation has no hard disk drives, only Test Options 0, 1, 2, 3, and 4 appear on this menu. The individual tests are described briefly below the figure of the menu.



Adapter Diagnostics Three pass/fail tests are run on the SCSI controller to check ROM, RAM, and the SCSI data bus.

Device Diagnostics This function issues the Device Diagnostics command to the selected device. If the device is a removable media type, it prompts for media to be inserted. If the command completes successfully, the selected device is installed and functioning properly.

Test Unit Ready This command is issued to each device to check that the device is online and ready to accept command requests.

Get Device Status If either the Test Unit Ready, Read, or Read/Write test resulted in an error condition, you should run Get Device Status to isolate the specific problem causing the error condition.


Read Test This test issues Read commands from the beginning to the end of the entire drive to verify that the drive processes them properly.





Read/Write Test This test issues Write commands, the Reads them back and compares the two to verify that they are handled properly by the drive. This test will destroy any data you may have on the drive.

Low-Level Format Drive This function will perform a low-level format of your drive, destroying any data that it may have on it. It is not necessary to run unless your SCSI device was used previously in another configuration. New drives do not require Low-Level Format Drive.



Chapter 6. Solving Problems



Computer and Dock I problems can be caused by your computer, the Dock I, or both. To simplify diagnosing problems, isolate your computer and diagnose it first. Then test the Dock I with the computer attached. The diagnostic program on your computer diagnoses the Dock I and the computer when attached. Many problems can be diagnosed and solved with the assistance of the self-tests and the diagnostics programs of your computer.

By using the diagnostics programs on your computer, you may be able to solve the problem yourself or provide information to the service representative. Make a note of all error messages and be prepared to give them to the service representative if you need to call for service. If the diagnostics programs on your computer cannot be loaded, refer to the troubleshooting charts and other information supplied with your computer.

The troubleshooting charts and other information in this chapter will help you determine what corrective action to take for the Dock I.

Important -

Use this chapter to test *IBM products only*. Other products may cause misleading error information or incorrect computer responses. Refer to the instructions supplied with those products for testing information.

When the computer is attached to the Dock I, you can start up the operating system from the additional hard disk in the Dock I.

The procedures for starting up the operating system from the additional hard disk varies depending on which operating system you have installed on the additional hard disk.

Planning for the Operating System Startup

When you attach the computer to the Dock I, keep in mind the following.

When installing the operating system, confirm the following.

- The configuration of all additional hard disks attached to the Dock I.
- All external SCSI devices are turned on.

The drive letter assigned to the partitions on the computer and on the additional hard disk may change when the computer is attached to the Dock I. When the originally-assigned drive letter for the hard disk is changed, as shown in the following examples, the operating system cannot be started up correctly.




Figure A-1. Drive Letters assigned to the computer. The drive letter assigned to the partition containing OS/2 2.1 is drive D.

Additional Hard Disk



For more information, refer to the manuals that came with the operating system.

Warning:

The assigned drive letters will vary depending on the defined startup sequence and on the operating system or the device drivers used. If you have changed your startup sequence in the Easy-Setup menu, you must be extremely careful when you do write operations, such as copying, saving, or formatting. Your data or programs will be overwritten if you select the wrong drive.

Only one startup sequence can be stored in the computer. The result of starting up the operating system will vary if the computer is attached to another Dock I that has different configurations for the additional hard disk.







Starting DOS

To start up DOS from the additional hard disk attached to the Dock I, you must change the startup sequence.

To change the startup sequence, do the following.

1.

Install the additional hard disk to the Dock I.

2.

Check the devices you have installed or attached.




Device Ordering and the Boot Drive

Hard disk drives are recognized by the system in the order of the SCSI controller's memory addresses (for multiple controllers). This is followed by the order of the SCSI ID of each hard disk drive on each SCSI controller in the system, starting at SCSI ID 6 through SCSI ID 0.

If there are only SCSI hard disk drives in a system, the boot drive is located on the SCSI controller at the lowest memory address and on the hard disk drive with the highest SCSI ID number.



Termination

The SCSI controller specification defines cable and termination requirements as listed below.

The Dock I has an active termination. Observe the following rules to use SCSI devices.

Internal SCSI device: Always terminate.

External SCSI devices: Terminate only the last SCSI device.

All SCSI buses require termination. The following guidelines must be followed to ensure proper operation of the SCSI bus and SCSI controllers.

Two terminations must be present on the bus. More than two terminations may damage the SCSI controller or option devices, or compromise data integrity. Make sure that the terminators are in place on the end device on either side of the SCSI bus (a total of two only).

The SCSI controller provides termination power (TERMPWR) to the SCSI bus on Pin 26 of the internal and external SCSI connectors. TERMPWR is protected by a thermal self-resetting fuse located on the SCSI controller.

SCSI Cable Length Specifications

The Dock I SCSI controller specification for the SCSI cable length connected to each SCSI interface is three meters (approximately 10



4

ft) maximum. This three-meter length includes both internal SCSI cables (inside the Dock I or external SCSI device) as well as external SCSI cables (outside the Dock I or external SCSI device).



When an adapter card, for example, an audio adapter card, is installed in the Dock I, an application program that enables the adapter card to operate is loaded into the memory of the computer. When you use the computer in a stand-alone mode the application program does not need to be loaded into the memory of the computer.

The application program can be loaded automatically when the computer is attached to the Dock I. To do this, modify the AUTOEXEC.BAT file (for the DOS sample) or the STARTUP.CMD file (for the OS/2 sample) as follows. The QExpUnit.EXE file is on the Utility Diskette supplied with the computer.


